

# Sequoia Heights Camp & Conference Grounds

## Renters Information

- For fire and health safety smoking is NOT allowed on campgrounds.
- Renters must provide certification for camp nurse, and food service certification for kitchen supervisor, lifeguard for use of lake.
- Grounds, buildings, equipment, and natural landscape and wildlife must be protected from vandalism, and damage from misuse.
- Renters are responsible for any and all damages to campground in connection to their prospective use.
- Christian values and respect are of the utmost importance, therefore criminal behavior, vulgar language or actions, and violence will not be tolerated. Expulsion from the campgrounds may result for those involved up to and including workers.
- A walk through review will be conducted with the camp director and renter representative upon arrival, to review policies and facility use.
- Before leaving the campground at the end of renter's scheduled use, the camp director will review the condition and cleanliness of the campground and facilities.
- All buildings must be cleaned; trash picked up, bagged and cans emptied into trash trailer. (This includes all grounds, trails, lake and meadow area, and main campus area).
- Showers, kitchen and Discovery center must be cleaned to the standards set by Tulare County health officials.
- Appliances and equipment must be used for their intended purpose only.
- All fire lanes must remain clear at all times to allow emergency vehicles access (Main roads, and areas within 50 feet of fire hydrants).
- There is a phone in Discovery center for emergency use, other uses must be approved by camp director.
- No holding tanks may be emptied from RVs except as connected and parked in RV area.
- RVs parked in RV area must have air conditioners, and heaters turned off when RVs are not occupied.
- Pets are NOT allowed. OR PETS are permitted only with prior approval
- All visitors are considered day use only, over night guests will be included in rental fees.
- Water is a precious resource in the Sierras, please do not wash any vehicles, or allow water to run unattended.
- Housekeeping: There is no daily housekeeping service. Renters will be expected to keep buildings and grounds clean during their event, and provide their own linens and amenities
- Kitchen use in houses must be preapproved by camp director.
- Any and all maintenance, repairs, alterations, and adjustments to all camp facilities, and equipment will be addressed by the camp director only.
- All of these guidelines will be subject to the camp director's interpretation.

### **In Case of Emergency Evacuation, please follow posted evacuation plan:**

- If there is a storm or fire, no refunds will be given unless:
- The state or local authorities order mandatory evacuations in a "Storm or Forest Fire Warning area"  
A "mandatory evacuation order has been given for the Storm or Forest Fire Warning" area of residence of a guest. The day that the authorities order a mandatory evacuation order, we will refund
- No refunds will be given for storms. [Mountain roads can be curvy and steep. Gravel drives are well maintained; however, we highly recommend four wheel drive and/or chains during the snow months. We do not refund due to road conditions.]

### **Tier 1 Minimum Fee**

\$14 per person per night.  
-tents, bathrooms and showers.

### **Tier 2 Fee**

\$16 per person per night.  
Includes tents, cabins, bathrooms and showers.  
Includes Dining Hall as a meeting room (Does not include kitchen).

### **Tier 3 Fee**

\$18 per person per night.  
Includes tents, cabins, bathrooms, showers, and full use of the kitchen and dining hall.

### **Additional Activities Fees**

**Release of Liability must be on file for each camper.**

Boats = \$75 per boat per day or \$150 per day for all three. (\$200 Deposit)

Water Park = \$100 per day. (\$200 Deposit)

Paintball Field = \$50 per day. (must provide own equipment)

Zip Line = \$100 per day. (Only open four hours per day) (Includes trained operator)
